The problem is that financial institutions often struggle to navigate and adapt the complex data models associated with FpML, which is updated multiple times per year.

As a result, organizations will be able to improve compliance with the FpML standard used throughout the OTC derivatives industry; additionally, they can improve organizational efficiencies and FpML adoption through a better understanding of FpML relationships.

Based on the award-winning <u>Progress DataXtend Semantic Integrator</u>, the DataXtend Browser for FpML will make it easier for organizations to search and understand complex FpML syntax and validation rules, compare disparate FpML data models, and better understand the FpML hierarchy and relationships. The new color-coded model, which the browser enables, offers developers and architects a more natural and intuitive way to view FpML syntax than the manual alternative of searching through vast sets of files.
