Explanation of Responses:

1. On January 20, 2022, the Reporting Person was granted 22,477 performance-based restricted stock units pursuant to Progress Software Corporation's (the "Company's") 2008 Stock Option and Incentive Plan and 2022 Long Term Incentive Plan. Based on the Company meeting relative total shareholder return and cumulative operating income criteria over the three-year period ending November 30, 2024, the amount shown is the amount of performance-based restricted stock units that vested under the 2022 Long Term Incentive Plan on February 1, 2025.
2. Restricted stock units convert into common stock on a one-for-one basis.
3. Represents shares of common stock withheld by the Company to pay the tax withholding obligations of the Reporting Person upon the vesting of performance-based restricted stock units granted to the Reporting Person on January 20, 2022.
4. The trading activity reported in this Form 4 was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on July 17, 2024.
5. This transaction was executed in multiple trades at prices ranging from \$55.26 to \$56.24 per share. The price reported represents the weighted average sale price of these trades.
